#### **NEW BUSINESS:** Dog/Cat Catcher

After the June 19, 2025, Regular Council meeting, Council instructed Administration to find a contractor for the purpose of catching dogs and cats outside of Public Works regular work hours. Administration has prepared a draft Dog/Cat Catcher Contractor Agreement for Council's review and consideration.

#### CMTA - \$5,000 Donation to Dove Society

As part of the funding received from the Small Communities Opportunity Program (SCOP), the Village engaged with CMTA for access to Grow Biz Skills. Part of the agreement was that CMTA would donate \$5,000 back to the Village, with the intent of the funds be forwarded to a non-profit organization, preferably the Dove Society for the mural project. They would like to have veterans incorporated into the mural.

#### Bylaw Enforcement – Appeal Notice

On June 3<sup>rd</sup> an order was sent regarding an electrical cord across the alley. On July 31, 2025, a final notice was sent regarding the same. On August 12, 2025, Administration received an appeal to the order. The reason for the appeal is "I need to run an electrical cord across the alley to my 5<sup>th</sup> Wheel Trailer to operate the fridge and freezer from time to time. The alley is pretty much unused by anyone but us. I would like to run a cord until I can install an electrical outlet on the north side of the alley."

#### 2025 Municipal Elections: Advance Poll

Local Authorities Elections Act (LAEA), Section 73(2) ... an elected authority may by resolution provide for holding an advance vote for an election. (6) The returning officer must determine the days and hours when the advance vote under subsection (2) or (3) is to be held.

**MOVED** by Mayor D. Rudolf that Council approves the holding of an advance poll for the upcoming election, to be scheduled in accordance with the applicable legislation, in order to increase accessibility and provide residents with additional opportunities to vote.

#### 2025 Municipal Elections: Elector Assistance At Home

Local Authorities Elections Act (LAEA), Section 79(1) An elected authority may by resolution provide for the attendance of 2 deputies at the residence of an elector, during the hours an advance voting station is open or other times as may be fixed by the resolution, in order to take the votes of an elector who, because of physical disability, is unable to attend a voting station or an advance voting station to vote.

**2025-125 MOVED** by Deputy Mayor R. Yaremchuk that Council authorize the attendance of two deputies at the residence of any elector who, due to a physical disability, is unable to attend a voting station or advance voting station, to assist in taking their vote before the advance polls are open.

#### 2025 Municipal Elections: Special Ballot

Local Authorities Elections Act (LAEA), Section 77.1(2) An elected authority may, by resolution passed prior to nomination day, provide for special ballots and provide that the application for special ballots may be made by any one or more of the following methods: (a) in writing; (b) by telephone; (c) by fax; (d) in person; (e) by e-mail; (f) by secure website.

## 2025-126 MOVED by Mayor D. Rudolf to accept as information. CARRIED 2025 Municipal Elections: Organizational Meeting

Municipal Government Act, Section 192(1) Except in a summer village, a council must hold an organizational meeting annually not later than 14 days after the 3rd Monday in October. The meeting allows Council to swear in elected officials, appoint deputies, establish committees, set meeting schedules, and address other administrative matters. It also provides an opportunity to ensure compliance with mandatory training requirements for elected officials under MGA Section 202.1, which must be held prior to or on the same day as the first organizational meeting.

**2025-127 MOVED** by Deputy Mayor R. Yaremchuk that Council hold its organizational meeting for the 2025-2026 term of office on November 3, 2025.

#### **2025 Council Orientation**

Municipal Government Act, Section 201.1(1) A municipality, in accordance with the regulations, must offer, and each councillor must attend, orientation training (a) on the following topics, to be held prior to or on the same day as the first organizational meeting following a general election required by section 192, or in the case of a councillor elected at a by-election, on or before the day that councillor takes the oath of office: (i) role of municipalities in Alberta; (ii) municipal organization and function; (iii) roles and responsibilities of council and councillors; (iv) repealed 2025 c13 s2(7); (v) roles and responsibilities of the chief administrative officer and staff, and (b) on the following topics, to be held prior to or on the same day as the first regularly scheduled council meeting, or in the case of a councillor elected at a by-election, within 90 days after that councillor takes the oath of office: (i) key municipal plans, policies and projects; (ii) budgeting and financial administration; (iii) public participation; (iv) any other topic prescribed by the regulations.

Yaremchuk that Council delegate the Chief Administrative Officer to organize and schedule the full orientation training for all newly elected officials for the 2025–2029 term of office to be held prior to or on the same day as the Organizational Meeting, and to manage all administrative arrangements while ensuring compliance with 201.1 of the Municipal Government Act.
